RESOLUTION AUTHORIZING THE 2021 ANNUAL BUDGET OF BARANGAY TEBAG IN THE AMOUNT OF FOUR MILLION THREE HUNDRED FOURTEEN THOUSAND TWO HUNDRED NINETEEN PESOS AND 25/100 (P4,314,219.25) OPERATIVE FOR THEIR OPERATIONS COVERING THE FISCAL YEAR 2021 AS CONTAINED IN THEIR APPROPRIATION ORDINANCE DULY APPROVED BY THEIR SANGGUNIANG BARANGAY.

WHEREAS, forwarded to this body is Annual Budget for Fiscal Year 2021 of Barangay Tebag, Mangaldan, Pangasinan as authorize by the Sangguniang Barangay under their Appropriation Ordinance No. 04;

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan authorizes the 2021 Annual Budget of Barangay Tebag in the amount of Four Million Three Hundred Fourteen Thousand Two Hundred Nineteen Pesos and 25/100 (P4,314,219.25) operative for their operations covering the Fiscal Year 2021 as contained in their Appropriation Ordinance duly approved by their Sangguniang Barangay;
