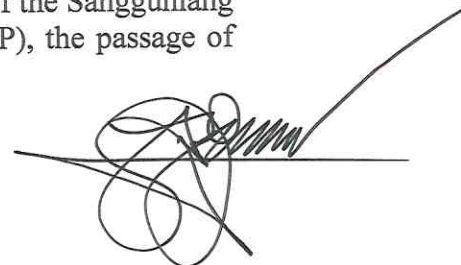
RESOLUTION NO. **2021 – 05**

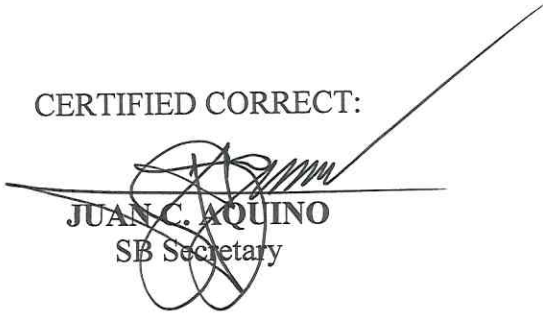

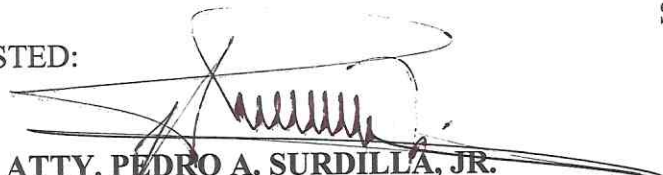
