RESOLUTION AUTHORIZING THE 2021 ANNUAL BUDGET OF BARANGAY MALABAGO IN THE AMOUNT OF SEVEN MILLION FOUR HUNDRED SIXTEEN THOUSAND SEVEN HUNDRED SEVENTY FOUR PESOS AND 74/100 (P7,416,774.74) OPERATIVE FOR THEIR OPERATIONS COVERING THE FISCAL YEAR 2021 AS CONTAINED IN THEIR APPROPRIATION ORDINANCE DULY APPROVED BY THEIR SANGGUNIANG BARANGAY.
