

RESOLUTION NO. 2021 - 08

RESOLUTION APPROVING THE APPLICATION OF ENGR. MARIO R. ALZONA FOR AN ALTERATION OF DEVELOPMENT PLAN "GUILLERMO MEMORIAL PARK/PYRAMID MEMORIAL PARK" LOCATED AT BARANGAY GUILIG, MANGALDAN, PANGASINAN, FOR LOCATIONAL CLEARANCE FOR THE PROPOSED CREMATORIUM AND COLUMBARIUM BUILDING TO BE CONSTRUCTED THEREAT.

WHEREAS, the Sanggunian Bayan received the application of Engr. Mario R. Alzona requesting for a resolution approving for an Alteration of Development Plan for the issuance of Locational Clearance for the proposed construction of a crematorium and columbarium building at Barangay Guilig, Mangaldan, Pangasinan;

WHEREAS, pursuant to Section 447 (a), (2), (x) of the Local Government Code of 1991 otherwise known as the Republic Act 7160, the Sanggunian Bayan shall, subject to national law, process and approve subdivision plans for residential, commercial, or industrial purposes and other development purposes, and collect processing fees and other charges, the proceeds of which shall accrue entirely to the municipality;



WHEREAS, Locational Clearance is a basic requirement in securing permits for all types of construction to promote compatibility of land development patterns based on the approved zoning ordinance;


WHEREAS, after careful review and thorough deliberation of the documents and requirements submitted duly verified and certified by the zoning administrator to be in conformity with the existing laws, rules and standards of P.D. No. 957, the Sangguniang Bayan decided to grant the Locational Clearance applied for by herein Engr. Mario R. Alzona;

WHEREFORE, on joint motion of Councilor Joel C. Meneses and Councilor Aldrin O. Soriano duly seconded by the remaining members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan approves the application of Engr. Mario R. Alzona for an Alteration of Development Plan "Guillermo Memorial Park/Pyramid Memorial Park" located at Barangay Guilig, Mangaldan, Pangasinan, for Locational Clearance for the proposed crematorium and columbarium building to be constructed thereat;




