RESOLUTION NO. 2021 – 09


RESOLUTION ADOPTING AND APPROVING THE LOCAL
SCHOOL BOARD PLAN 2021 OF THE MUNICIPALITY OF
MANGALDAN, PANGASINAN.

WHEREAS, pursuant to Section 99 (a) of Republic Act No. 7160 of the
Local Government Code states that one of the functions of the Municipal School
Board is to determine, in accordance with the criteria set by the Department of
Education (DepEd) the annual needs for the operation and maintenance of public
schools within the municipality;

WHEREAS, submitted to this Sanggunian the Local School Board
Resolution No. 01, Series of 2021 regarding the Local School Board Plan 2021 of
the Municipality of Mangaldan, Pangasinan for favorable action;

WHEREAS, as the entire education system braces for the changes brought
about by the pandemic, Local Government Unit urges to look into the needs of the
schools in their respective areas;

WHEREAS, as we face the new normal in the education system due to
COVID-19 situation, the Department of Education (DepEd) is eyeing the utilization
of the Special Education Fund (SEF);



WHEREAS, the SEF of the Local Government Units play a big part or factor of the Bayanihan system that will lead the shift to the new normal in education;

WHEREAS, giving the Local School Board leeway on the use of the SEF will provide much-needed additional resources to protect learners, teachers, and school personnel from the COVID-19 threat;


