
RESOLUTION NO. 2021 – 107

RESOLUTION AUTHORIZING THE 2021 ANNUAL BUDGET OF BARANGAY BUENLAG IN THE AMOUNT OF FOUR MILLION EIGHT HUNDRED FORTY THREE THOUSAND EIGHT HUNDRED SIX PESOS AND 50/100 (P4,843,806.50) OPERATIVE FOR THEIR OPERATIONS COVERING THE FISCAL YEAR 2021 AS CONTAINED IN THEIR APPROPRIATION ORDINANCE DULY APPROVED BY THEIR SANGGUNIANG BARANGAY.




