
RESOLUTION NO. **2021 – 111**

RESOLUTION AUTHORIZING THE 2021 ANNUAL BUDGET  
OF BARANGAY BATENG IN THE AMOUNT OF FOUR  
MILLION FIVE THOUSAND TWO HUNDRED TWENTY  
PESOS ONLY (P4,005,220.00) OPERATIVE FOR THEIR  
OPERATIONS COVERING THE FISCAL YEAR 2021 AS  
CONTAINED IN THEIR APPROPRIATION ORDINANCE  
DULY APPROVED BY THEIR SANGGUNIANG BARANGAY.

WHEREAS, forwarded to this body is Annual Budget for Fiscal Year 2021

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan authorizes the 2021 Annual Budget of Barangay Bateng in the amount of Four Million Five Thousand Two Hundred Twenty Pesos only (P4,005,220.00) operative for their operations covering the Fiscal Year 2021 as contained in their Appropriation Ordinance duly approved by their Sangguniang Barangay;


