RESOLUTION NO. 2021 – 112

RESOLUTION APPROVING BARANGAY ORDINANCE NO. 01,  
SERIES OF 2021 OF THE SANGGUNIANG BARANGAY OF  
BATENG, "AN ORDINANCE IMPOSING FEES AND CHARGES  
ON INDIVIDUAL BARANGAY CLEARANCE, BARANGAY  
CLEARANCE FOR BUSINESS PERMITS, BARANGAY  
CLEARANCE FOR BUILDING PERMITS AND OTHER  
SERVICES OFFERED BY THIS BARANGAY PURSUANT TO  
THE PROVISIONS OF THE LOCAL GOVERNMENT CODE (RA  
7160) AND PROVIDING PENALTY FOR VIOLATION  
THEREOF" AS WITHIN THE CONFERRED POWERS OF THE  
SANGGUNIANG BARANGAY TO ENACT.

WHEREAS, the Sangguniang Barangay of Bateng forwarded its Barangay  
Ordinance No. 01, Series of 2021 to Sangguniang Bayan for legislative measures  
and consideration;

WHEREAS, Section 447 (a)(1)(i) of Republic Act No. 7160 otherwise  
known as the Local Government Code of 1991, the Sangguniang Bayan as the  
legislative body is empowered to review ordinances approved by the Sangguniang  
Barangay to determine whether these are within the scope of the prescribed powers  
of the sanggunian;

**WHEREAS**, Section 152 in relation to Section 153 and Section 186 of the same Code, vested to every Local Government Unit, including the barangay to impose and collect fees for any service rendered in the amount commensurate to such service provided, and powers to create its own sources of revenue and impose fees and charges which shall accrue exclusively to the LGU concerned;

**WHEREAS**, there are official activities of the barangay which are urgently required to meet the exigencies of delivering basic services to the community and such activities need appropriate fund to meet its objective;

**WHEREAS**, a JMC No. 2019-01 was issued to ensure that impose fees do not unduly burden the public but are imposed only to help local government recover the costs of services they rendered while making them more business friendly, in compliance with RA No. 11032 or the Ease of Doing Business and efficient Government Service Delivery Act an as provided under the Local Government Unit;

**WHEREAS**, evaluation of the Sanggunian shows that the said Ordinance imposing fees and charges has been enacted in accordance with pertinent provision of the Local Government Code;

**WHEREFORE**, on motion of Councilor Atty. Fernando Juan A. Cabrera duly seconded by other members present:

**RESOLVED**, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan approves Barangay Ordinance No. 01, Series of 2021 of the Sangguniang Barangay of Bateng, “An Ordinance Imposing Fees and Charges on individual Barangay Clearance, Barangay Clearance for Business Permits, Barangay Clearance for Building Permits and other services offered by this Barangay pursuant to the provisions of the Local Government Code (RA 7160) and providing penalty for violation thereof” as within the conferred powers of the Sangguniang Barangay to enact;


