RESOLUTION APPROVING BARANGAY ORDINANCE NO. 04, SERIES OF 2021 OF THE SANGGUNIANG BARANGAY STRICTLY "AN **ORDINANCE** OF NIBALIW, IMPLEMENTING IMPOUNDMENT FEE TO OWNERS OF ALL KINDS OF ASTRAY ANIMALS FOUND IN THE **PLACES** WITHIN **OTHER** AND STREETS TERRITORIAL JURISDICTION OF BARANGAY NIBALIW, THE PANGASINAN" AS WITHIN MANGALDAN, SANGGUNINAG OF THE **POWERS** CONFERRED BARANGAY TO ENACT.

WHEREAS, the Barangay Council of Nibaliw, Mangaldan, Pangasinan submitted for review and evaluation its Barangay Ordinance No. 04, Series of 2021, implementing impoundment fee to owners of all kinds of astray animals;

WHEREAS, the Local Government Code provide, "the barangay may levy taxes, fees and charges which shall exclusively accrue to them";

WHEREAS, it is a reality that stray dogs can cause a collision when dogs run into the road, which might even result in injury to other people. Moreover,

astray dogs have become a bigger threat to human health and lives, transfer and spread rabies a deadly disease;

WHEREAS, it can negatively impact delicate ecosystem through pollution and the spreading of disease. Astray animals usually aren't vaccinated leading to the transmission of life- threatening diseases to other animal population;

WHEREAS, the Committee on Rules, Laws and Ordinances conducted initial review and evaluation on the documents submitted and found out that the same is in order and enacted within the conferred powers of the barangay;

WHEREAS, after thorough review and evaluation on the subject Barangay Ordinance, the Sangguniang Bayan on its regular session finally found the foregoing ordinance to be in order;

WHEREFORE, on motion of Councilor Atty. Fernando Juan A. Cabrera duly seconded by other remaining members present:

RESOLVED, as it is hereby resolved by the Sangguniang Bayan of Mangaldan, Pangasinan approves Barangay Ordinance No. 04, Series of 2021 of the Sangguniang Barangay of Nibaliw, "An Ordinance strictly implementing Impoundment Fee to owners of all kinds of astray animals found in the streets and other places within the territorial jurisdiction of Barangay Nibaliw, Mangaldan, Pangasinan" as within the conferred powers of the Sangguniang Barangay to enact;
