
RESOLUTION NO. 2021 – 122

RESOLUTION APPROVING BARANGAY ORDINANCE NO. 02,
SERIES OF 2021 OF THE SANGGUNIANG BARANGAY OF
EMBARCADERO, “AN ORDINANCE AUTHORIZING THE
MUNICIPALITY OF MANGALDAN TO ISSUE BARANGAY
CLEARANCE AND COLLECT CORRESPONDING BARANGAY
CLEARANCE FEE IN THE APPLICATION FOR ANY BUSINESS
RELATED TRANSACTIONS SUBJECT TO THE REMITTANCE
OF THE AFORESAID FEES TO THE BARANGAY AND THE
CONDITION HEREUNDER” AS WITHIN THE CONFERRED
POWERS OF THE SANGGUNIANG BARANGAY TO ENACT.

WHEREAS, pursuant to Memorandum Circular No. 2019-177 “Provides
Guidelines in the Integration of the Issuance of Barangay Clearance in the
permitting processes of Cities and Municipalities”;

WHEREAS, endorse to this Sanggunian a Barangay Ordinance No. 02,
Series of 2021 of the Sangguniang Barangay of Embarcadero for a thorough study
and review;

WHEREAS, this direction is consistent with the Ease of Doing Business
and Efficient Delivery of Government Services Act or R.A. 11032, which covers



all LGU's that provide services covering business and non-business-related transactions;

WHEREAS, said Memorandum Circular is in compliance to section 11 (f) of R.A. 11032 requires, that Barangay Clearance and Permits related to doing business shall be applied, issued and collected at the City/Municipality in accordance with the prescribed processing time of this Act;

WHEREFORE, on motion of Councilor Atty. Fernando Juan A. Cabrera duly seconded by all the remaining members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan approves Barangay Ordinance No. 02, Series of 2021 of the Sangguniang Barangay of Embarcadero, "An Ordinance Authorizing the Municipality of Mangaldan to issue Barangay Clearance and collect corresponding Barangay Clearance Fee in the Application for any business related transactions subject to the remittance of the aforesaid fees to the barangay and the condition hereunder" as within the conferred powers of the Sangguniang Barangay to enact;


RESOLVED FURTHER, that copies of this resolution be furnished the Sangguniang Barangay of Embarcadero through Punong Barangay Teofilo G. Frianeza, Jr., the MLGOO, Mrs. Romarie P. Lambino and all other authorities concerned for their information and favorable action.
