RESOLUTION NO. <u>2021 – 132</u>

RESOLUTION AUTHORIZING THE 2021 ANNUAL BUDGET OF BARANGAY ANOLID IN THE AMOUNT OF EIGHT MILLION TWO HUNDRED SIXTY NINE THOUSAND FOUR HUNDRED NINETY TWO PESOS AND 02/100 (P8,269,492.02) OPERATIVE FOR THEIR OPERATIONS COVERING THE FISCAL YEAR 2021 AS CONTAINED IN THEIR APPROPRIATION ORDINANCE DULY APPROVED BY THEIR SANGGUNIANG BARANGAY.

WHEREAS, forwarded to this body is Annual Budget for Fiscal Year 2021 of Barangay Anolid, Mangaldan, Pangasinan as authorize by the Sangguniang Barangay under their Appropriation Ordinance No. 1;

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan authorizes the 2021 Annual Budget of Barangay Anolid in the amount of Eight Million Two Hundred Sixty Nine Thousand Four Hundred Ninety Two Pesos and 02/100 (P8,269,492.02) operative for their operations covering the Fiscal Year 2021 as contained in their Appropriation Ordinance duly approved by their Sangguniang Barangay;
