RESOLUTION NO. 2021 – 134

RESOLUTION APPROVING AND ADOPTING THE  
SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP)  
NO. 3, CY 2021 OF THE MUNICIPALITY OF MANGALDAN,  
PANGASINAN.

WHEREAS, the Local Government of Mangaldan, Pangasinan in  
compliance to Republic Act No. 7160, particularly Section 106, otherwise known  
as the Local Government Code of the Philippines sets to implement projects,  
programs and activities in the direction of economic and social development in the  
local government;

WHEREAS, the Municipal Development Council Executive Committee  
(MDC-EXEC) through its Resolution No. 3, Series of 2021, the Local Government  
of Mangaldan identified and approved priority programs, projects and activities  
vital to the Supplemental Annual Investment Program (AIP) for CY 2021 which  
has a total funding requirement of P32,184,000.00 of which the stated funding is  
forecast to derived through outsourcing. The CY 2021 Supplemental Annual
