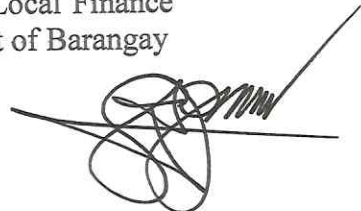
RESOLUTION NO. 2021 – 137

RESOLUTION AUTHORIZING THE 2021 ANNUAL BUDGET
OF BARANGAY MACAYUG IN THE AMOUNT OF THREE
MILLION FIVE HUNDRED NINETEEN THOUSAND TWO
HUNDRED FORTY NINE PESOS AND 22/100 (P3,519,249.22)
OPERATIVE FOR THEIR OPERATIONS COVERING THE
FISCAL YEAR 2021 AS CONTAINED IN THEIR
APPROPRIATION ORDINANCE DULY APPROVED BY
THEIR SANGGUNIANG BARANGAY.

WHEREAS, forwarded to this body is Annual Budget for Fiscal Year 2021

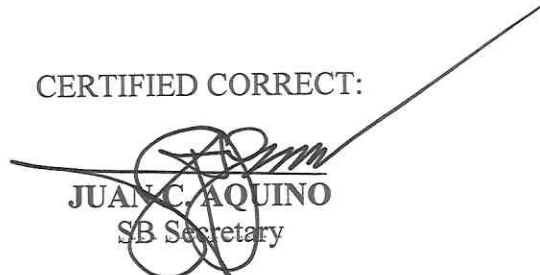
