RESOLUTION STRONGLY INDORSING TO THE
DEPARTMENT OF BUDGET AND MANAGEMENT FOR
FINANCIAL ASSISTANCE AND SUPPORT IN THE TOTAL
AMOUNT OF P17,861,898.00 FOR THE AFORECITED
PROJECTS TO BE FUNDED UNDER THE LOCAL
GOVERNMENT UNIT SHARES FROM TOBACCO EXCISE
TAX VARIOUS FISCAL YEARS COVERED UNDER DBM
LOCAL BUDGET MEMORANDUM NOS. 76 AND 79 DATED
OCTOBER 6, 2017 AND JUNE 14, 2019, RESPECTIVELY.

WHEREAS, Section 444, (b)(1), the Local Chief Executive shall exercise
general supervision and control over all programs, projects, services, and activities
of the municipal government;

WHEREAS, it further ensure the delivery of basic services and the
provision of adequate facilities as provided for under Section 17 of the Local
Government Code;

WHEREAS, the Local Chief Executive upon Sangguniang Bayan

pursuant to law, Section 444 (b) (1)(iv);




