RESOLUTION NO. 2021 – 145

RESOLUTION STRONGLY APPROVING AND ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 4, CY 2021 FOR THE ACQUISITION OF AMBULANCE (2 UNITS) AND ACQUISITION OF DUMP TRUCKS (3 UNITS) TO BE FUNDED UNDER THE FY 2021 LOCAL GOVERNMENT SUPPORT FUND-OTHER FINANCIAL ASSISTANCE TO LOCAL GOVERNMENT UNITS (LGSF-OTHER FA TO LGUS).

WHEREAS, the Local Government Unit of Mangaldan, Pangasinan in compliance to Republic Act No. 7160, particularly Section 106, otherwise known as the Local Government Code of the Philippines sets to implement projects, programs and activities in the direction of economic and social development in the local government;

WHEREAS, pursuant to Chapter III, Article I, Section 25 (c) of RA No. 7160, otherwise known as the Local Government Code, the President may, upon request of the local government unit concerned, direct the appropriate national agency to provide financial, technical, or other forms of assistance to the local government unit. Such assistance shall be extended at no extra cost to the local government unit concerned;

WHEREAS, Section 17 (a)(b)(iii) of the same Code , Local Government Unit vested the power to discharge the functions and responsibilities of national agencies which are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities, such as health services which include the implementation of programs and projects on primary health care and equipment needed to carry out the herein services;

WHEREAS, the Municipal Development Council Executive Committee (MDC-EXEC) through its Resolution No. 2, Series of 2021, the Local Government of Mangaldan identified and approved priority programs, projects and activities vital to the Supplemental Annual Investment Program (AIP) for CY 2021 which has a total funding requirement of P10,000,000.00, stated funding is forecast to derived through outsourcing;

WHEREAS, aforesaid priority programs initiative are meant to sustain responsiveness of government service by improving social and health services, enhancing infrastructure support facilities and pursuing operational effectiveness;

WHEREAS, after careful review, deliberation and consideration, the same is found to be in conformity with the thrust of the municipal government and contribute to the attainment of the development goals and objective of the municipality;

WHEREFORE, on motion of Councilor Atty. Joseph Emmanuel B. Cera duly seconded by all the remaining members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan strongly approves and adopts the Supplemental Annual Investment Program (AIP) No. 4, CY 2021 for the acquisition of Two (2) Units of Ambulance and Three (3) Units of Dump Trucks, to be funded under the FY 2021 Local Government Support Fund-Other Financial Assistance to Local Government Units (LGSF-OTHER FA TO LGUS);


