RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. MARY MARILYN DG. LAMBINO TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) ON BEHALF OF THE MUNICIPAL GOVERNMENT OF MANGALDAN WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) - FIELD OFFICE 1 FOR THE SUPPLEMENTARY FEEDING PROGRAM IN DAY CARE CENTERS OR ANY OTHER FACILITY USED FOR SUCH PURPOSE, PURSUANT TO REPUBLIC ACT NO. 11037.

WHEREAS, the Supplementary Feeding Program is the provision of food in addition to the regular meals, to target children as part of the DSWD's contribution to the Early Childhood Care and Development (ECCD) programs of the government;

WHEREAS, pursuant to 1987 Philippine Constitution Art. XV, Section 3 item 2, provides, the State must ensure the right of children to assistance including proper care and nutrition and special protection from all forms of neglect, abuse, exploitations and other conditions prejudicial to their development;

WHEREAS, PD 603 or the Child and Youth Welfare Code, states that every effort should be exerted to promote children's welfare and enhance their opportunity for a useful and happy life;

WHEREAS, the Municipal Government of Mangaldan recognizes the importance of the program to improve and sustain the nutritional status of all target children and ensure their access to any appropriate health unit regarding their nutrition-related problems including overweight and at risk of malnutrition conditions:

WHEREAS, it is the objective of this feeding program to provide or improve knowledge, attitude and practices of children enrolled in any Day Care Centers, parents and caregivers through intensified nutrition and education;

WHEREFORE, on motion of Councilor Christopher G. Romero duly seconded by all other remaining members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan authorizes the Local Chief Executive, Hon. Mary Marilyn DG. Lambino to enter into a Memorandum of Agreement (MOA) on behalf of the Municipal Government of Mangaldan with the Department Social Welfare and Development (DSWD) - Field Office 1 for the Supplementary Feeding Program in Day Care Centers or in any other facility used for such purpose, pursuant to RA No. 11037;
