
RESOLUTION SUPPORTING THE SURVIVAL RIGHTS OF  
CHILDREN IN THE MUNICIPALITY OF MANGALDAN,  
PANGASINAN.

WHEREAS, Section 13 of the 1987 Philippine Constitution provides, “the youth plays the vital role in nation-building and shall promote and protect their physical, moral, spiritual, intellectual and social well-being. It shall inculcate in the youth patriotism and nationalism and encourage their involvement in public and civic affairs”;

WHEREAS, recognizing that the child, for the full and harmonious development of his or her personality, should grow up in a family environment, in an atmosphere of happiness, love and understanding;

WHEREAS, the family, as the fundamental group of society and the natural environment for the growth and well-being of all its members and particularly children, should be afforded the necessary protection and assistance so that it can fully assume its responsibilities within the community;

WHEREAS, survival rights embodied child’s right to life and the needs that are most basic to existence, such as nutrition, shelter, and adequate living



standard and access to medical services; the right to protection from harmful influences, abuse and exploitation; and the right to participate fully in family, cultural and social life;

WHEREAS, the Local Government Unit as the prime mover in the delivery of basic services, has the task and responsibility to formulate plans, programs, activities and appropriate formulas to ensure implementation and sustainability for the welfare of children;

WHEREFORE, on motion of Councilor Maria Teresa M. Abalos duly seconded by all the remaining members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan supports the Survival Rights of Children in the Municipality of Mangaldan, Pangasinan;


