RESOLUTION NO. 2021 – 158

RESOLUTION AUTHORIZING THE LOCAL CHIEF
EXECUTIVE, HON. MARY MARILYN DG. LAMBINO, TO
SIGN, FOR AND ON BEHALF OF LGU MANGALDAN, ALL
DEEDS AND DOCUMENTS RELATIVE TO THE TRANSFER
OF ALL ASSETS, IN ACTUAL AND CONSTRUCTIVE
POSSESSION OF THE MUNICIPALITY, BOTH PERSONAL
AND REAL, IN THE NAME AND OWNERSHIP OF LGU
MANGALDAN, PANGASINAN.

WHEREAS, the Municipality of Mangaldan, Pangasinan through its leaders
from previous administrations to the present has acquired properties both personal
and real. Unfortunately, some of these properties are not yet registered under the
name of the Local Government Unit of Mangaldan, Pangasinan;

WHEREAS, it is the noblest intention of the present administration to
collate the lists of all personal and real properties of the municipal government to
be subjected for registration and for accessible monitoring in adherence to the call
for transparency and accountability;

WHEREAS, the Local Chief Executive shall exercise such powers and
perform such duties and functions and ensure the delivery of basic services and the

provision of adequate facilities as provided for under Section 17 of the Local Government Code;

WHEREAS, Chapter III, Article I, Section 444 (b)(1)(vi) states, the Local Chief Executive in exercising its powers and upon authorization of the Sangguniang Bayan, may represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and documents, and such other documents pursuant to law or ordinance;

WHEREAS, par (b)(2)(xi) of the same section, the local chief executive may even examine the books, records and other document of all offices, officials, agents or employees of the municipality and in aid of his executive powers and authority may assigned to the municipality to make available to him such books, records and other documents in their custody, except those classified by law as confidential;

WHEREAS, this initiative aims to deliver a smooth and harmonious operating mechanism to meet the needs and services of the community;

WHEREFORE, on motion of Councilor Atty. Fernando Juan A. Cabrera duly seconded by all the remaining members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan authorizes the Local Chief Executive, Hon. Mary Marilyn DG. Lambino, to sign, for and on behalf of LGU Mangaldan all deeds and documents relative to the transfer of all assets, in actual and constructive possession of the municipality, both personal and real, in the name and ownership of LGU Mangaldan, Pangasinan;

RESOLVED FURTHER, that copies of this resolution be furnished the General Services Officer, Mr. Fernando Saguisag A. Cabrera, the MLGOO, Mrs. Romarie P. Soriano, the Commission on Audit through Mrs. Marina P. De Guzman, Audit Team Leader, the Office of the Municipal Mayor, Hon. Mary Marilyn DG. Lambino and all other authorities concerned for their information and favorable action.


