RESOLUTION REMANDING ORDINANCE NO. 01, SERIES OF 2021 OF THE SANGGUNIANG BARANGAY OF POBLACION, "AN ORDINANCE IMPOSING FEES AND CHARGES ON CLEARANCE, BARANGAY BARANGAY INDIVIDUAL **CLEARANCE** FOR **BUSINESS** PERMITS, BARANGAY FOR BUILDING PERMITS AND CLEARANCE SERVICES OFFERED BY THIS BARANGAY PURSUANT TO THE PROVISIONS OF THE LOCAL GOVERNMENT CODE (RA AND PROVIDING PENALTY FOR VIOLATION 7160) THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BARANGAY TO ENACT.

WHEREAS, pursuant to Section 447 (a)(1)(i) of Article III, provides that, the Sangguniang Bayan, as the legislative body shall review, enact ordinances, approved resolutions for the general welfare of its inhabitants pursuant to Section 16 and in the exercise of the corporate powers of the municipality as provided for under Section 22 of the Code;

WHEREAS, the Barangay Council of Poblacion submitted to Sangguniang Bayan of Mangaldan, Pangasinan for review, evaluation and approval of their Ordinance No. 01, Series of 2021, "An Ordinance imposing fees and charges on

Individual Barangay Clearance, Barangay Clearance for Business Permits, Barangay Clearance for Building Permits and other services offered by this barangay pursuant to the provisions of the Local Government Code (RA 7160) and providing penalty for violation thereof" as within the conferred powers of the Sangguniang Barangay to enact;

WHEREAS, the Sangguniang Bayan invited the Barangay Council Officials of Barangay Poblacion to attend the Committee Hearing on July 16, 2021 for the deliberation of their proposed Ordinance;

WHEREAS, Mr. Federico B. Limon II, OIC-Office of the Punong Barangay was the only Barangay Official attended the Committee Hearing, while the other six (6) members of the Sangguniang Barangay of Poblacion wrote a letter dated July 16, 2021 and have signified their intention not to participate in the said Committee Hearing for reasons mentioned in their letter;

WHEREAS, the members of the August Body noticed that the fees and charges stipulated in Ordinance No. 01, Series of 2021 are almost similar to the fees and charges that was stipulated in Ordinance No. 11, S. 2019 and Ordinance No. 13, S. 2020 which were remanded to Barangay Poblacion for the same cause;

WHEREAS, in view of the foregoing circumstance, this Sanggunian opted to determine the validity of the proposed ordinance based on the merits of the available documents presented. Notwithstanding the fact that during the deliberation it was found out through the testimony of Mr. Federico B. Limon II, OIC-Office of the Punong Barangay that Barangay Ordinance No. 01, Series of 2021 has not complied with the required public hearing as prescribed by the local government code;

WHEREAS, after thorough review and evaluation on the subject ordinance, this Sanggunian decided to return the same for reasons mentioned above;

WHEREFORE, on motion of Councilor Atty. Fernando Juan A. Cabrera duly seconded by all the members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan remands Ordinance No. 01, Series of 2021 of the Sangguniang Barangay of Poblacion, "An Ordinance imposing fees and charges on Individual Barangay Clearance, Barangay Clearance for Business Permits, Barangay Clearance for Building Permits and other services offered by this barangay pursuant to the provisions of the Local Government Code (RA 7160) and providing penalty for violation thereof" as within the conferred powers of the Sangguniang Barangay to enact;

RESOLVED FURTHER, that copies of this resolution be furnished the Sangguniang Barangay of Poblacion through Mr. Federico B. Limon II, OIC-Office of the Punong Barangay, the MLGOO, Mrs. Romarie P. Soriano, the Commission on Audit through Mrs. Marina P. De Guzman, Audit Team Leader, the Office of the Municipal Mayor, Hon. Mary Marilyn DG. Lambino and all other authorities concerned for their information and favorable action.
