


RESOLUTION NO. 2021 – 185

RESOLUTION AUTHORIZING THE LOCAL CHIEF
EXECUTIVE, HON. MARY MARILYN DG. LAMBINO TO
ENTER INTO A MEMORANDUM OF AGREEMENT (MOA)
ON BEHALF OF THE MUNICIPALITY OF MANGALDAN
WITH THE DEPARTMENT OF AGRICULTURE-REGIONAL
FIELD OFFICE 1 AS A RECIPIENT OF ONE (1) UNIT OF
POWER SPRAYER.

WHEREAS, aware of the government economic recovery efforts, the
Department of Agriculture (DA) continues to implement much-needed
interventions to match the scale of the challenges posed by the COVID-19
pandemic;

WHEREAS, with the intention to uplift the people's standard of living, the
Department of Agriculture-Regional Field Office I (DA-RFO1) through the
National Livestock Program (NLP) is directed to promote livestock and poultry
modernization to increase productivity and profitability of farmers;

WHEREAS, the existence of equipment and machineries to Local
Government Units (LGUs) and Farmer's Cooperative Association plays an

important factor in the stabilization and recovery mechanisms under the livestock program;

WHEREAS, the Local Chief Executive (LCE) seeks to enter into a Memorandum of Agreement (MOA) with the DA-RFO1 for the grant of One (1) Unit of Power Sprayer in favor of the LGU of Mangaldan;


