### RESOLUTION NO. <u>2021 – 198</u>

RESOLUTION APPROVING AND ADOPTING THE MUNICIPAL DISASTER RISK REDUCTION MANAGEMENT (MDRRM) ACTION PLAN 2022 AND MONITORING AND EVALUATION 2022.

WHEREAS, Republic Act No. 10121 or the Philippine Disaster Risk Reduction and Management Act of 2010, "An Act Strengthening the Philippine Disaster Risk Reduction and Management System, providing for the National Disaster Risk Reduction and Management Framework and institutionalizing the National Disaster Risk Reduction and Management Plan, granted LGUs greater flexibility towards disaster mitigation, preparation, response, rehabilitation and recovery";

WHEREAS, the Municipal Disaster Risk Reduction and Management Plan 2022 articulates the municipal aspirations to enhance its disaster resiliency in support of sustainable development: providing for the well-being of its constituents through the delivery of the highest level of basic social and economic services, competent, responsible and professional civil servants;

WHEREAS, it is the policy of the Municipal Government of Mangaldan, Pangasinan to uphold, adopt and incorporate people's constitutional right to life and property by addressing the root causes of vulnerabilities to disaster, strengthening its capacity for disaster risk reduction and the management and building the resilience of local communities to disaster including the impact of climate change;

WHEREFORE, on motion of Councilor Atty. Joseph Emmanuel B. Cera duly seconded by all the remaining members present:

RESOLVED, as it is hereby resolved by the Sangguniang Bayan of Mangaldan, Pangasinan approves and adopts the Municipal Disaster Risk Reduction Management (MDRRM) Action Plan 2022 and Monitoring and Evaluation 2022;
