

RESOLUTION NO. 2021 – 199

RESOLUTION AUTHORIZING THE LOCAL CHIEF
EXECUTIVE, MAYOR MARY MARILYN DG. LAMBINO, ON
BEHALF OF LGU MANGALDAN, TO ENTER INTO A
MEMORANDUM OF AGREEMENT (MOA) WITH THE
DIFFERENT BARANGAYS OF THE MUNICIPALITY TO
PROVIDE MENTAL HEALTH AND PSYCHOSOCIAL
SUPPORT SERVICES TO BARANGAY ELECTED AND
APPOINTED OFFICIALS WHO ARE AFFECTED BY THE
COVID-19 PANDEMIC.

WHEREAS, many psychological problems and important consequences in
terms of mental health including stress, anxiety, depression, frustration, uncertainty
during COVID-19 outbreak emerged progressively;

WHEREAS, the unprecedented situation related to COVID-19 is clearly
demonstrating that individuals are largely and emotionally unprepared to the
detrimental effects of biological disasters that are directly showing how everyone
may be frail and helpless;

WHEREAS, specific preventive strategies at the community level such as
implementing effective communication and providing adequate psychological

services should be carried out in order to attenuate the psychological and psychosocial impact of COVID-19 outbreak;

WHEREFORE, on motion of Councilor Dr. Joselito G. Quinto duly seconded by all other members present:

RESOLVED, as it is resolved that the Sangguniang Bayan of Mangaldan, Pangasinan authorizes the Local Chief Executive, Mayor Mary Marilyn DG. Lambino, on behalf of LGU Mangaldan, to enter into a Memorandum of Agreement (MOA) with the different barangays of the municipality to provide mental health and psychosocial support services to barangay elected and appointed officials who are affected by the COVID-19 pandemic;
