
RESOLUTION NO. 2021 – 20

APPROVING AND CONFIRMING THE APPOINTMENT OF MR. PEDRITO N. RIVERA AS MUNICIPAL GOVERNMENT DEPARTMENT HEAD I (MUNICIPAL ENVIRONMENT AND NATURAL RESOURCES), (SG 24) OF THE MUNICIPAL GOVERNMENT OF MANGALDAN, PANGASINAN EFFECTIVE UPON APPROVAL OF APPOINTMENT.

WHEREAS, Article XIV, Section 484 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991 states “no person shall be appointed Environment and Natural Resources Officer unless he is a citizen of the Local Government Unit concerned, of good moral character, a holder of a college degree preferably in environment, forestry, agriculture or any related course from a recognized college or university, and a first grade civil service eligible or its equivalent”. He must have acquired experience in Environment and Natural Resource Management, conservation, and utilization, for at least three (3) years in the case of the Municipal Government and Natural Resources Officer;

WHEREAS, the position of Municipal Environment and Natural Resources Officer (MENRO) was created on September 27, 2019 through Sangguniang Bayan Ordinance No. 2019 – 128;

WHEREAS, the filling up of the position of the Municipal Environment and Natural Resources Officer is deemed necessary by the municipal government of



Mangaldan, Pangasinan in carrying out the delivery of basic services relative to Environmental and Natural Resources protection for the welfare of the people pursuant to the provisions of Section 17 of the Local Government Code of 1991;

WHEREAS, the Human Resource Merit Promotion and Selection Board (HRMPSB) convened a meeting on July 7, 2020 to tackle, deliberate and take action on the applications of two (2) insider and ten (10) outsider applicants to the position of the Municipal Environment and Natural Resources Officer (MENRO). Corollary to this, they favored the application of Mr. Pedrito N. Rivera based on the merit of experiences and other qualifications appurtenant to the position;

WHEREAS, Mr. Pedrito N. Rivera was hired in 2007 as Consultant on Solid Waste Management and Disaster Risk Reduction Management. On July 2009, he was appointed as Agricultural Technologist. On 2011, he was promoted and appointed as Market Supervisor III and on that period to date was designated in concurrent capacity as Solid Waste Management Focal Person;

WHEREAS, the appointment of Mr. Pedrito N. Rivera was submitted to the Sangguniang Bayan for confirmation and concurrence of the August Body;

WHEREAS, after careful study and deliberation on the document submitted to the Sangguniang Bayan of Mangaldan, Pangasinan, it was found out that Mr. Pedrito N. Rivera has met all the requirements set forth by law appurtenant to the position of Municipal Government Department Head 1 (Municipal Environment and Natural Resources Officer), (SG 24) of the Municipal Government of Mangaldan, Pangasinan;

WHEREFORE, on motion of Councilor Atty. Fernando Juan A. Cabrera, and duly seconded by all the members present:


RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan approves and confirms the appointment of Mr. Pedrito N. Rivera as Municipal Government Department Head I (Municipal Environment and Natural Resources Officer), (SG 24) of the Municipal Government of Mangaldan, Pangasinan effective upon approval of appointment;


