

RESOLUTION ALLOWING THE LOCAL GOVERNMENT
UNIT OF MANGALDAN REPRESENTED BY THE LOCAL
CHIEF EXECUTIVE, HON. MARY MARILYN DG. LAMBINO
TO ACCEPT TRANSFER OF OWNERSHIP OF THE
FOLLOWING VEHICLES: 1.) NISSAN TRUCK (1987); 2.)
ISUZU MINI TANKER (2001); AND 3.) TOYOTA REVO (2003)
WITHOUT ANY COST FROM OUR END IN ACCORDANCE
WITH THE METROPOLITAN WATERWORKS AND
SEWERAGE SYSTEM BOARD RESOLUTION NO. 2020-084-
CO DATE OCTOBER 22, 2020.

WHEREAS, pursuant to Section 23 of Republic Act No. 7160, otherwise
known as the Local Government Code of 1991, the Local Chief Executive may
upon authority of the Sangguniang, negotiate and secure financial grants or
donation in kind in support of the basic services or facilities enumerated under
section 14 thereof, from local and foreign agencies;

WHEREAS, the Municipal Government of Mangaldan, Pangasinan take the
initiative to allow the Local Chief Executive, Hon. Mary Marilyn DG. Lambino to
facilitate the acceptance of transfer of ownership of second hand vehicles;



WHEREAS, motor vehicles are indispensable for the efficient and effective performance and delivery of essential government services;

WHEREAS, for and in consideration of the goodwill, assistance and pure generosity of the Metropolitan Waterworks and Sewerage System through its Board Resolution No. 2020-084 hereby voluntary and freely transfer and conveys by way of donation, unto the Municipality of Mangaldan three (3) units of motor vehicles;

WHEREAS, on motion of Councilor Atty. Fernando Juan A. Cabrera duly seconded by the all other members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan allows the Local Government Unit of Mangaldan represented by Local Chief Executive, Hon. Mary Marilyn DG. Lambino to accept Transfer of Ownership of the following vehicles: 1.) Nissan Truck (1987); 2.) Isuzu Mini Tanker (2001); and 3.) Toyota Revo (2003) without any cost from our end in accordance with the Metropolitan Waterworks and Sewerage System Board Resolution No. 2020-084-CO dated October 22, 2020;
