RESOLUTION REQUESTING HONORABLE MAYOR MARY MARILYN DG. LAMBINO TO GRANT FINANCIAL ASSISTANCE TO OUR FORMER PRIDE OF MANGALDAN, THE FORMER THREE (3) TIME SECOND PLACER IN NATIONAL CYCLING TOUR, MR. CESAR CERA CATAMBAY FOR HIS MEDICAL EXPENSES FOR TREATMENT OF HIS PHYSICAL DISABILITY.

WHEREAS, the Municipality of Mangaldan, Pangasinan was adjudged as the home of cycling champions;

WHEREAS, Mr. Cesar Cera Catambay is one of the living proofs to this claim as the latter was a three-time First Runner-up of then Champion Mr. Jesus A. Garcia during their prime time in 1973 and 1974 Tour of Luzon and in 1983 Marlboro Tour, respectively;

WHEREAS, it is unfortunate that Mr. Catambay suffered from stroke for the second time and presently confined in the hospital; WHEREAS, as way of expressing gratitude and acknowledging the honor, pride and prestige he had accorded our Municipality, the Sangguniang Bayan of Mangaldan have thought of granting financial assistance to Mr. Cesar Cera Catambay to augment his medical expenses;
