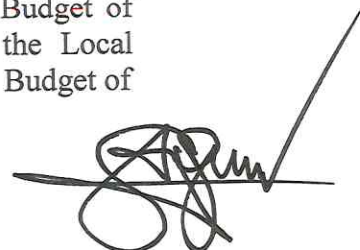
RESOLUTION NO. 2021 - 207

RESOLUTION AUTHORIZING THE 2021 ANNUAL BUDGET OF BARANGAY GUIGUILONEN IN THE AMOUNT OF FOUR MILLION THREE HUNDRED THIRTY NINE THOUSAND NINE HUNDRED SIXTY THREE PESOS AND 81/100 (P4,339,963.81) OPERATIVE FOR THEIR OPERATIONS COVERING THE FISCAL YEAR 2021 AS CONTAINED IN THEIR APPROPRIATION ORDINANCE DULY APPROVED BY THEIR SANGGUNIANG BARANGAY.

WHEREAS, forwarded to this body is Annual Budget for Fiscal Year 2021 of Barangay Guiguilonen, Mangaldan, Pangasinan as authorize by the Sangguniang Barangay under their Appropriation Ordinance No. 1;

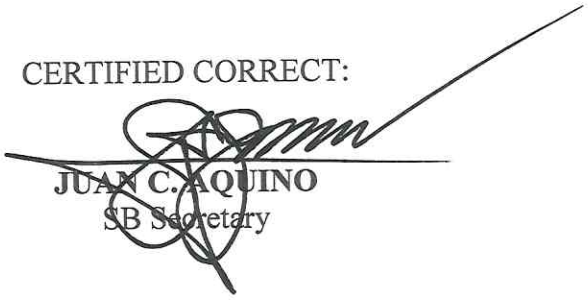

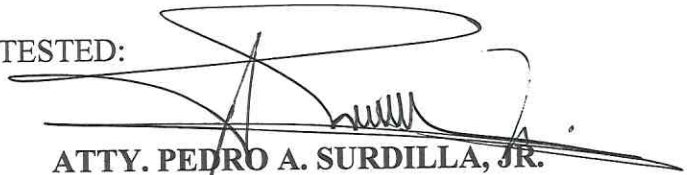
