


RESOLUTION ADOPTING MANGALDAN MPS
DEPLOYMENT PATROL PLAN 08-2021 IN PREVENTING
AND CONTROLLING THE MOBILITY OF MOTORCYCLE-
RIDING SUSPECTS IN THE MUNICIPALITY OF
MANGALDAN FOR MAINTENANCE OF PEACE, ORDER
AND SECURITY ON THE COMMUNITY.

WHEREAS, Article II, Section 5 of 1987 Philippine Constitution provides
that “the maintenance of peace and order, the protection of life, liberty and
property, and promotion of the general welfare are essential for the enjoyment by
all the people of the blessings of democracy”;

WHEREAS, police authorities typically are responsible for maintaining
public order and safety, enforcing the law, and preventing, detecting, and
investigating criminal activities;

WHEREAS, the Mangaldan Police Station has on its record several
shooting incidents which are perpetrated by motorcycle-riding suspects (MRS);

WHEREAS, there is a need to enhance managing police operations
(EMPO) to ensure the safety and security of the public and to prevent motorcycle-

riding suspects to perform their criminal intent and eliminate opportunity in consummating their unlawful acts;

WHEREAS, the Sangguniang Bayan of Mangaldan is cognizant and in full support on the exerted efforts by the PNP Mangaldan for the maintenance of peace and order situation of our town;

WHEREFORE, on motion of Councilor Atty. Joseph Emmanuel B. Cera duly seconded by all other members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan adopts Mangaldan MPS Deployment Patrol Plan 08-2021 in preventing and controlling the mobility of Motorcycle-Riding Suspects in the Municipality of Mangaldan, Pangasinan for maintenance of peace, order and security on the community;


