

RESOLUTION NO. 2021 – 216

RESOLUTION APPROVING BARANGAY RESOLUTION NO. 10,
SERIES OF 2021 OF THE SANGGUNIANG BARANGAY OF
LANAS, MANGALDAN, PANGASINAN, ENTITLED “STRONGLY
ENDORISING THE SUPPLEMENTAL ANNUAL INVESTMENT
PROGRAM (AIP) NO. 1, CY 2021 OF BARANGAY LANAS,
MANGALDAN, PANGASINAN”.

WHEREAS, pursuant to Section 16 of R.A. 7160, otherwise known as the Local Government Code of 1991, provides that, every Local Government Unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary appropriate, or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdiction, local government unit shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balance ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, Section 384 of the same Code, mentioned, that as a basic political unit, the barangay serves as the primary planning and implementing unit of government policies, plans, projects, programs, and activities in the community;



WHEREAS, Barangay Council of Lanas has submitted its Resolution No. 10, Series of 2021 their Annual Investment Program (AIP) CY 2021 Supplemental No. 1 to Sangguniang Bayan for appropriate legislative action;

WHEREAS, the Sangguniang Bayan, as the legislative body, is empowered to enact ordinance, approve resolutions and authorize annual or supplemental fund for the general welfare and in the manner prescribed by law, Section 447 (R.A. 7160);

WHEREAS, during the deliberation, it was decided by the Body with the concurrence of the Barangay Officials of Barangay Lanas present to change, by a stroke of a pen, the title of their Resolution No. 10, and change the word “for” to “from” before the phrase “Purchase of Rescue Vehicle” and which read as “Strongly Endorsing the Annual Investment Program (AIP) CY 2021 Supplemental No. 01 for the realignment of funds of the 20% Development Fund “from” the Purchase of Rescue Vehicle for Barangay Lanas, Mangaldan, Pangasinan in the amount of Five Hundred Thousand Pesos only (P500,000.00)”. Apparently, they are realigning the allotted amount of Five Hundred Thousand Pesos (P500,000.00) which they originally allotted for the purchase of Rescue Vehicle and that they are now intending to use the said amount for the Construction, Installation of Barangay Streetlights LED;

WHEREAS, this Sanggunian finds the merit of the aforementioned Supplemental Annual Investment Plan and has satisfactorily met the requirements set forth under the law, as certified by the Local Finance Committee, hence, declares feasible and effective;


WHEREFORE, on motion of Councilor Atty. Joseph Emmanuel B. Cera duly seconded by the remaining members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan approves Barangay Resolution No. 10, Series of 2021 of the Sangguniang Barangay of Lanas, Mangaldan, Pangasinan, entitled “Strongly Endorsing the Supplemental Annual Investment Program (AIP) No. 1, CY 2021 of Barangay Lanas, Mangaldan, Pangasinan”;
