RESOLUTION NO. <u>2021 – 22</u>

RESOLUTION AUTHORIZING THE 2021 ANNUAL BUDGET OF BARANGAY GUESANG IN THE AMOUNT OF FOUR MILLION SEVEN HUNDRED THIRTEEN THOUSAND THREE HUNDRED SEVENTY ONE PESOS AND 68/100 (P4,713,371.68) OPERATIVE FOR THEIR OPERATIONS COVERING THE FISCAL YEAR 2021 AS CONTAINED IN THEIR APPROPRIATION ORDINANCE DULY APPROVED BY THEIR SANGGUNIANG BARANGAY.

WHEREAS, forwarded to this body is Annual Budget for Fiscal Year 2021 of Barangay Guesang, Mangaldan, Pangasinan as authorize by the Sangguniang Barangay under their Appropriation Ordinance No. 1;

WHEREAS, pursuant to Section 333 of R.A. 7160, of the Local Government Code of 1991, the Sangguniang Bayan is vested with power to review the barangay ordinance authorizing the annual appropriations in order to ensure that the provisions pertinent therein are complied with;

Guesang is complete in form and substance and found to be in order and had complied with all the budgetary requirements of the Local Government Code of 1991, and in conformity with the Annual Investment Plan of Barangay Guesang;

WHEREFORE, on joint motion of Councilor Atty. Joseph Emmanuel B. Cera and Councilor Atty. Fernando Juan A. Cabrera duly seconded by other members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan authorizes the 2021 Annual Budget of Barangay Guesang in the amount of Four Million Seven Hundred Thirteen Thousand Three Hundred Seventy One Pesos and 68/100 (P4,713,371.68) operative for their operations covering the Fiscal Year 2021 as contained in their Appropriation Ordinance duly approved by their Sangguniang Barangay;
