LAMBINO, TO ENTER INTO A MEMORANDUM OF UNDERSTANDING AND/OR MEMORANDUM OF AGREEMENT ON BEHALF OF THE MUNICIPAL GOVERNMENT OF MANGALDAN WITH DEVELOPMENT BANK OF THE PHILIPPINES FOR AN ELECTRONIC PAYMENT AND COLLECTION SYSTEM.
