

RESOLUTION NO. 2021 – 227

RESOLUTION REMANDING BARANGAY ORDINANCE NO.
4, S. 2021 OF THE SANGGUNIANG BARANGAY OF
TALOGTOG, “IN VIEW OF MUNICIPAL ORDINANCE NO.
2021-12, THE BARANGAY OFFICIALS OF TALOGTOG,
MANGALDAN, PANGASINAN ADOPTS; AN ORDINANCE
AND ENFORCING THE MINIMUM PUBLIC HEALTH
STANDARDS AND PROTOCOLS AND PROVIDING
PENALTIES FOR QUARANTINE-RELATED VIOLATIONS,
AND OTHER RELATED VIOLATION DURING THE PUBLIC
HEALTH EMERGENCY IN THE MUNICIPALITY OF
MANGALDAN, PANGASINAN”.

WHEREAS, the aforementioned Barangay submitted to this Sanggunian for
review, evaluation and approval of their Barangay Ordinance No. 4, S. 2021, “In
view of Municipal Ordinance No. 2021-12, the Barangay Officials of Talogtog,
Mangaldan, Pangasinan adopts; An Ordinance and enforcing the Minimum Public
Health Standards and Protocols and providing penalties for quarantine-related
violations, and other related violation during the public health emergency in the
Municipality of Mangaldan, Pangasinan”;



WHEREAS, the Committee on Rules, Laws and Ordinances of the Sangguniang Bayan of Mangaldan, Pangasinan conducted initial review and evaluation on the documents submitted. Apparently, they found out that the subject of said Barangay Ordinance of herein Barangay did not conformed with the required procedure in enacting an Ordinance as prescribed by R.A. 7160 of the Local Government Code. Accordingly, the Committee noticed that the required public hearing was not satisfied;

WHEREAS, after thorough review and evaluation of the submitted Barangay Ordinance, this Body during its session decided to return the said Ordinance to the aforesaid Barangay for reasons mentioned above;

WHEREFORE, on motion of Councilor Atty. Fernando Juan A. Cabrera duly seconded by all the members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan remands Barangay Ordinance No. 4, S. 2021 of the Sangguniang Barangay of Talogtog, "In view of Municipal Ordinance No. 2021-12, the Barangay Officials of Talogtog, Mangaldan, Pangasinan adopts; An Ordinance and enforcing the Minimum Public Health Standards and Protocols and providing penalties for quarantine-related violations, and other related violation during the public health emergency in the Municipality of Mangaldan, Pangasinan";


