## RESOLUTION NO. <u>2021 – 234</u>

RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. MARY MARILYN DG. LAMBINO TO ISSUE GUIDELINES IN ESTABLISHING BIKE LANES IN THE MUNICIPALITY OF MANGALDAN, PANGASINAN.

WHEREAS, Article II, Section 15 of the Constitution provides, "the State shall protect and promote the right to health of the people and instill health consciousness among them";

WHEREAS, pursuant to DILG Joint Administrative Order (JAO) No. 2020-0001, urging LGUs to construct protected biking lanes and walking paths as alternative modes of transportation amid the COVID-19 crisis;

WHEREAS, public transportation has become vulnerable to Corona-virus transmission which is why biking and walking is encouraged for they present less contact leading to less opportunities of infection;

WHEREAS, biking opens up various benefits for the health of an individual, contribute to less air pollution, address and help in easing public transportation, and most importantly, decrease the likelihood of COVID-19 transmission;

WHEREAS, the LGU Mangaldan is cognizant on the urgency of DILG JAO giving attention to identify local road structures and sections that may be develop into bike lanes;

WHEREFORE, on motion of Councilor Joel C. Meneses duly seconded by all other members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan authorizes the Local Chief Executive, Hon. Mary Marilyn DG. Lambino to issue guidelines in establishing Bike Lanes in the Municipality of Mangaldan, Pangasinan;
