RESOLUTION APPROVING BARANGAY RESOLUTION NO. 26, SERIES OF 2021 OF THE SANGGUNIANG BARANGAY OF MALABAGO, MANGALDAN, PANGASINAN, ENTITLED “RESOLUTION APPROVING AND ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 2, CY 2021 OF BARANGAY MALABAGO, MANGALDAN, PANGASINAN”.

WHEREAS, pursuant to Section 16 of R.A. 7160, otherwise known as the Local Government Code of 1991, provides that, every Local Government Unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary appropriate, or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdiction, local government unit shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balance ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREFORE, on motion of Councilor Atty. Joseph Emmanuel B. Cera duly seconded by the remaining members present:




