RESOLUTION NO. 2021 – 242

RESOLUTION APPROVING AND ADOPTING THE ANNUAL
INVESTMENT PROGRAM (AIP) CY 2022 OF THE
MUNICIPALITY OF MANGALDAN, PANGASINAN.

WHEREAS, the Fundamental Principle on Fiscal Administration as
provided for under Section 305 of the Local Government Code of 1991, otherwise
known as Republic Act of 7160, are being observed by the local administration of
Mangaldan, Pangasinan to see to it that every centavo of the people's money is
properly accounted for and utilized for its intended purpose for the benefits and
welfare of the public;

WHEREAS, Section 106 of the same Local Government Code of 1991
provide that each local government unit shall have a comprehensive multi-sectoral
development plan to be initiated b y its development council and approved by its
Sanggunian. For this purpose, the Municipal Development Council shall assist the
Sanggunian in setting the direction of economic and social development and
coordinating development efforts within its territorial jurisdiction;

WHEREAS, the Municipal Development Council passed and approved
Resolution No. 4, S. 2021, "Strongly Endorsing the Annual Investment Program
(AIP) CY 2022 of the Municipality of Mangaldan, Pangasinan";

WHEREAS, the Annual Investment Program (AIP) CY 2022 which contains the priority development projects needing urgent implementation in the municipality was carefully consolidated by the Municipal Development Council Secretariat through the Municipal Planning and Development Coordinator's Office;

WHEREAS, the members of the Sangguniang Bayan of Mangaldan have thoroughly discussed and deliberated the programs, projects and activities embodied in the Annual Investment Program (AIP) CY 2022. 
