RESOLUTION NO. 2021 - 256

RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. MARY MARILYN DG.LAMBINO TO NEGOTIATE WITH INTERESTED LOT OWNERS TO BE UTILIZED AS TRIPLE "AAA" SLAUGHTERHOUSE IN THE MUNICIPALITY.

WHEREAS, pursuant to Chapter I, Section 16 of Republic Act No. 7160 of the Local Government Code of 1991 "every local government shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balance ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants";

WHEREAS, Section 17of the same Local Government Code provides that (a) Local Government Units shall endeavor to be self-reliant and shall continue

exercising the powers and discharging the duties and functions currently vested upon them. They shall also discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this Code. Local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic services and facilities.(b)such basic services and facilities include, but are not limited to the following: (2) x xx, (ix) Public markets, slaughterhouses and other municipal enterprises;

WHEREAS, the local administration has thought of upgrading the taxonomy of the municipal abattoir from double "AA" to triple "AAA" classification by constructing a new and world class slaughterhouse that would cater and support the demand of quality meat products and further boost the future of meat industry in the municipality;

WHEREAS, Section 444 (a) (b) (1) (vi) of Republic Act No. 7160 provides that upon authorization by the Sangguniang Bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREFORE, on motion of Councilor Joel C. Meneses duly seconded by all other members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan authorizes the Local Chief Executive, Hon. Mary Marilyn DG. Lambino to negotiate with interested lot owners to be utilized as Triple "AAA" Slaughterhouse in the Municipality;

RESOLVED FURTHER, that copies of this resolution be furnished the MLGOO, Mrs. Romarie P. Soriano, the Commission on Audit through Mrs. Marina P. De Guzman, Audit Team Leader, the Office of the Municipal Mayor, Hon. Mary Marilyn DG. Lambino and all other authorities concerned for their information and favorable action.
