RESOLUTION NO. 2021 – 257


RESOLUTION ALLOWING TEMPORARILY THE OPERATION OF FOOD STRIPS WITHIN THE VICINITY OF THE MUNICIPAL PLAZA FROM DECEMBER 1, 2021 UNTIL JANUARY 15, 2022.

WHEREAS, for almost two years, people were pre-occupied with guidelines on how to celebrate Christmas – with only members of the family who are living in the same household can participate in the celebration, discouraging others from visiting one another for their mutual protection and safety because of the onslaught of COVID-19 pandemic;

WHEREAS, the government is continuously giving advice to the public to celebrate Christmas responsibly, not to be complacent and to remain vigilant of the possible presence of the new variant, Omicron;

WHEREAS, pursuant to Section 15 of the 1987 Philippine Constitution, “the State shall protect and promote the right to health of the people and instill health consciousness among them”;

WHEREAS, the celebration this year should not be dampened by the present pandemic situation rather, maybe celebrated with utmost strict compliance



with minimum health and safety protocols considering the government's action to slowly ease restrictions so as to revitalize the economy;

WHEREAS, in connection with Christmas celebration, the local government unit of Mangaldan designated a portion of the municipal plaza for the operation of food strips to its constituents in the observance of Yuletide season;

WHEREAS, Christmas is one of the most important holidays people love to celebrate with family, relatives, and friends, it is the time of the year when families usually reunite and do things with much fun, vigor and festivities;

WHEREFORE, on motion of Councilor Dr. Joselito G. Quinto duly seconded by all other members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan allows temporarily the operation of food strips within the vicinity of the municipal plaza from December 1, 2021 until January 15, 2022:


