RESOLUTION NO. 2021 - 258

RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. MARY MARILYN DG.LAMBINO TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) ON BEHALF OF THE MUNICIPALITY NOF MANGALDAN WITH METRO CLARK WASTE MANAGEMENT CORPORATION.

WHEREAS, Section 2 (a)(d) of Republic Act No. 9003 provides that, it is a declared policy of the State to adopt a systematic, comprehensive and ecological waste management program which shall ensure the protection of public health and environment and shall ensure greater private sector participation in the proper segregation, collection, transport, storage, treatment and disposal of solid waste through the formulation and adoption of the best environmental practice in ecological waste management;

WHEREAS, Section 447 (5)(xiii) of R.A. No. 7160 of the Local Government Code, provides for an efficient and effective system of solid waste and garbage collection and disposal and prohibit littering and the placing or throwing of garbage, refuse and other filth and wastes;



WHEREAS, the Local Government Unit of Mangaldan, Pangasinan has previously entered into a Memorandum of Agreement with Metro Clark Management Corporation for the service of hauling and disposal of solid wastes of the Municipality by virtue of Sangguniang Bayan Resolution No. 2020-205;

WHEREAS, the Local Government Unit of Mangaldan, Pangasinan focuses its concern on waste management so as to comply with the mandate of the national government to protect the environment for the welfare of the future generation;

WHEREAS, under Section 16 of the General Welfare Clause of local Government Code, xxx. Within their respective territorial jurisdictions, Local Government Units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhances the right of the people to a balance ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities xxx maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, Section 444 (i)(vi) of RA No. 7160 provides that the Local Chief Executive, upon authorization of the Sangguniang Bayan, represent the municipality in all its business transactions and obligations, and such other documents made pursuant to law or ordinance;

WHEREFORE, on motion of Councilor Aldrin O. Soriano duly seconded by all other members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan authorizes the Local Chief Executive, Hon. Mary Marilyn DG. Lambino to enter into a Memorandum of Agreement (MOA) on behalf of the Municipality of Mangaldan with Metro Clark Waste Management Corporation;
