
RESOLUTION ADOPTING AND APPROVING THE LOCAL
SCHOOL BOARD PLAN 2022 OF THE MUNICIPALITY OF
MANGALDAN, PANGASINAN.

WHEREAS, Section 1, Article XIV, of the 1987 Constitution of the
Philippines, provides, the State shall promote the right of all citizens to equally
education at all levels of education, and shall take appropriate steps to make such
education accessible to all;

WHEREAS, Section 98 (b) of Republic Act No. 7160, provides the creation
and composition of the Municipal School Board;

WHEREAS, one of the functions of the municipal school board is to
determine in accordance with the criteria set by the Department of Education
(DepEd), the annual needs for the operation and maintenance of public schools
within the municipality;

WHEREAS, the municipal government recognize the endeavor of the
Department of Education (DepEd) in the implementation of the programs, projects
and activities specified in the DepEd-DILG-DBM Joint Circular No. 1, Series of
2020 and the recent Joint Circular No. 2, Calendar Year 2020;



WHEREAS, the Local School Board of Mangaldan, Pangasinan, has formulated Local School Board Plan 2022 and endorsed the same to the Sangguniang Bayan on December 6, 2021 for its adoption and approval;

WHEREAS, after careful study and thorough deliberation, the said School Board Plan was determined to be in accordance with the provision of the Local Government Code;


WHEREFORE, on motion of Councilor Atty. Joseph Emmanuel B. Cera duly seconded by all other members present:
