
RESOLUTION NO. 2021 – 29

RESOLUTION AUTHORIZING THE 2021 ANNUAL BUDGET
OF BARANGAY BANTAYAN IN THE AMOUNT OF FOUR
MILLION FIVE HUNDRED FIFTY SEVEN THOUSAND FIVE
HUNDRED TWENTY ONE PESOS AND 86/100
(P4,557,521.86) OPERATIVE FOR THEIR OPERATIONS
COVERING THE FISCAL YEAR 2021 AS CONTAINED IN
THEIR APPROPRIATION ORDINANCE DULY APPROVED
BY THEIR SANGGUNIANG BARANGAY.

WHEREAS, forwarded to this body is Annual Budget for Fiscal Year 2021
of Barangay Bantayan, Mangaldan, Pangasinan as authorize by the Sangguniang
Barangay under their Appropriation Ordinance No. 5;

WHEREAS, pursuant to Section 333 of R.A. 7160, of the Local
Government Code of 1991, the Sangguniang Bayan is vested with power to review

Bantayan is complete in form and substance and found to be in order and had complied with all the budgetary requirements of the Local Government Code of 1991, and in conformity with the Annual Investment Plan of Barangay Bantayan;

WHEREFORE, on joint motion of Councilor Atty. Joseph Emmanuel B. Cera and Councilor Atty. Fernando Juan A. Cabrera duly seconded by other members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan authorizes the 2021 Annual Budget of Barangay Bantayan in the amount of Four Million Five Hundred Fifty Seven Thousand Five Hundred Twenty One Pesos and 86/100 (P4,557,521.86) operative for their operations covering the Fiscal Year 2021 as contained in their Appropriation Ordinance duly approved by their Sangguniang Barangay;


