RESOLUTION NO. 2021 – 32

RESOLUTION APPROVING AND ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 1, CY 2021 OF THE MUNICIPALITY OF MANGALDAN.

WHEREAS, the Local Government of Mangaldan, Pangasinan in compliance to Republic Act No. 7160, particularly Section 106, otherwise known as the Local Government Code of the Philippines sets to implement projects, programs and activities in the direction of economic and social development in the local government;

WHEREAS, the Municipal Development Council Executive Committee strongly endorsed to the Sangguniang Bayan its Resolution No. 01, series of 2021, RE: "Annual Investment Program (AIP) CY 2021 Supplemental No. 1 for the Reversion of other Employee Benefits to Finance the Implementation of salary Standardization Law (Second Tranche) and other Priority Projects for outsourcing in the Municipality of Mangaldan, Pangasinan".

WHEREAS, pursuant to the MDC Resolution No. 1, the allotted amount for the implementation of the salary Standardization Law (Second Tranche) amounts to Three Million Four Hundred Twenty-Eight Thousand Seven Hundred Thirty-Nine Pesos and Eighty-Eight Centavos (P3,428,739.88) whereas, the

identified budget for the other Priority Projects for Outsourcing is Sixty-Three Million Four Hundred Sixty-One Thousand Eight Hundred Ninety-Eight Pesos (P63,461,898.00);

WHEREAS, the aforesaid priority projects, programs and activities initiative are meant to recognize and further encourage the unwavering commitment/dedication of the all the civil servants in performing their duties in the delivery of services to the people and sustain responsiveness of government service by improving social and health services, enhancing infrastructure support facilities and pursuing operational effectiveness;

WHEREAS, the authority of the Local Chief Executive or the Presiding Officer of the Sanggunian concerned may, by ordinance, augment item in the approved supplemental Annual Investment Plan and Supplemental Budget for the legitimate utilization of the savings of the municipality and further implement the other projects, programs and activities derived through outsourcing;

WHEREAS, considering the urgency of the programs, projects, and activities embodied in the Plan and understood to be in conformity with the thrust of the local government unit contributing to the welfare of the officials, employees and the entire populace of the municipality, the Sangguniang Bayan felt the necessity to approve and adopt the resolution;

WHEREFORE, on motion of Councilor Atty. Joseph Emmanuel B. Cera duly seconded by the other members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan approves and adopts the Supplemental Annual Investment Program (AIP) No. 1, CY 2021 of the Municipality of Mangaldan, Pangasinan;

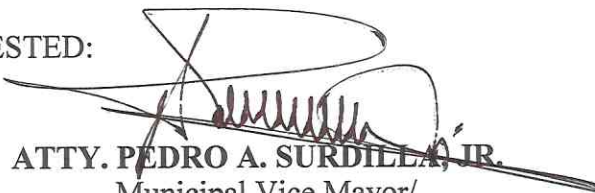
