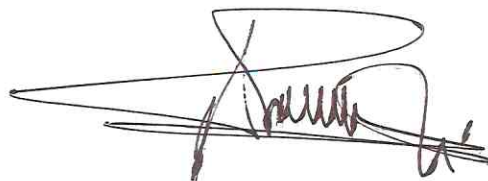

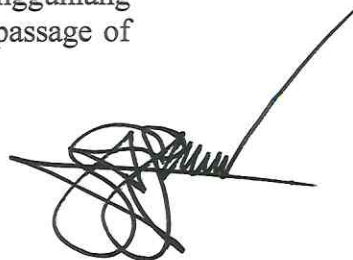
RESOLUTION NO. 2021 – 37

which is being in accordance with law;



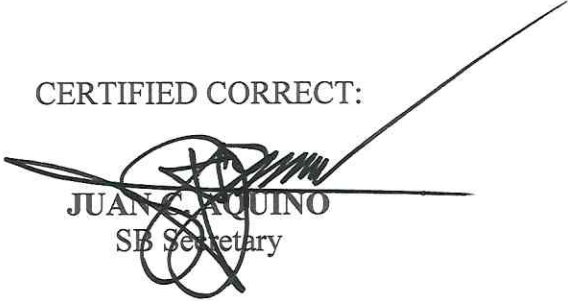

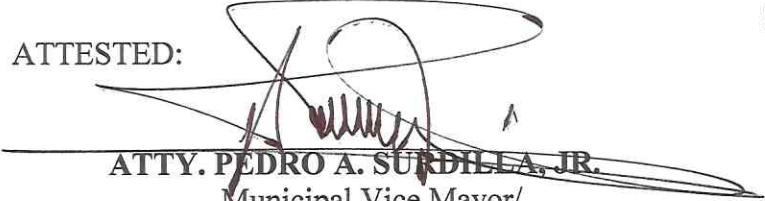
