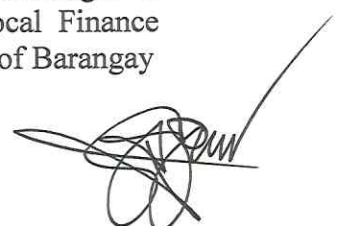
RESOLUTION NO. 2021 – 38

RESOLUTION AUTHORIZING THE 2021 ANNUAL BUDGET OF BARANGAY SALAY IN THE AMOUNT OF SIX MILLION THREE HUNDRED EIGHTY TWO THOUSAND ONE HUNDRED EIGHTY TWO PESOS (P6,382,182.00) OPERATIVE FOR THEIR OPERATIONS COVERING THE FISCAL YEAR 2021 AS CONTAINED IN THEIR APPROPRIATION ORDINANCE DULY APPROVED BY THEIR SANGGUNIANG BARANGAY.

WHEREAS, forwarded to this body is Annual Budget for Fiscal Year 2021 of Barangay Salay, Mangaldan, Pangasinan as authorize by the Sangguniang Barangay under their Appropriation Ordinance No. 03;

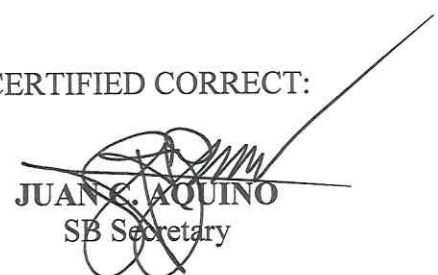

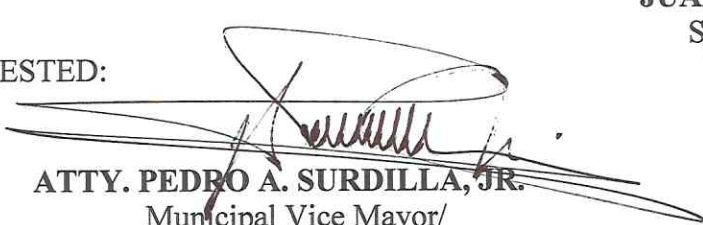
