adaptation, disaster risk reduction and resiliency, youth employment and livelihood, health and anti-drug abuse, social protection, capability building and sports development;

WHEREAS, after due deliberation the Sangguniang Bayan deemed it wise to approved the LYDP of Mangaldan, Pangasinan;


WHEREFORE, on motion of Councilor Michael Ervin C. Lomibao duly seconded by other members present:


