RESOLUTION NO. <u>2021 – 40</u>

RESOLUTION REMANDING BARANGAY ORDINANCE NO. 01, SERIES OF 2021 OF THE SANGGUNIANG BARANGAY AUTHORIZING "AN ORDINANCE OF BARI, MUNICIPALITY OF MANGALDAN, PANGASINAN TO COLLECT **BARANGAY CLEARANCE** AND **ISSUE** CORRESPONDING BARANGAY CLEARANCE FEE IN THE RELATED ANY BUSINESS APPLICATION FOR TRANSACTIONS SUBJECT TO THE REMITTANCE OF THE AFORESAID FEES TO THE BARANGAY AND THE CONDITION HEREUNDER".

WHEREAS, the aforementioned Barangay submitted to this Sanggunian for review, evaluation and approval of their Barangay Ordinance No. 01, Series of 2021, "An Ordinance Authorizing the Municipality of Mangaldan, Pangasinan to issue Barangay Clearance and Collect corresponding Barangay Clearance Fee in the application for any business related transactions subject to the remittance of the aforesaid fees to the Barangay and the condition hereunder";

WHEREAS, the Committee on Rules, Laws and Ordinances of the Sangguniang Bayan of Mangaldan, Pangasinan conducted initial review and evaluation on the documents submitted. Apparently, they found out that the subject

of said Barangay Ordinance of herein Barangay did not conformed with the required procedure in enacting an Ordinance as prescribed by R.A. 7160 of the Local Government Code. Accordingly, the Committee noticed that the required public hearing was not satisfied;

WHEREAS, it was resolved that the fees on the issuance of Barangay Clearance must be incorporated in the Revenue Code or Ordinance of the said Barangay;

WHEREAS, after thorough review and evaluation of the submitted Barangay Ordinance, this Body during its session decided to return the said Ordinance to the aforesaid Barangay for reasons mentioned above;

WHEREFORE, on motion of Councilor Atty. Fernando Juan A. Cabrera duly seconded by all the members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan remands Barangay Ordinance No. 01, Series of 2021 of the Sangguniang Barangay of Bari, "An Ordinance Authorizing the Municipality of Mangaldan, Pangasinan to issue Barangay Clearance and Collect corresponding Barangay Clearance Fee in the application for any business related transactions subject to the remittance of the aforesaid fees to the Barangay and the Condition hereunder";
