RESOLUTION NO. 2021 – 41

RESOLUTION STRONGLY ENDORSING TO THE
DEPARTMENT OF BUDGET AND MANAGEMENT FOR
FINANCIAL ASSISTANCE AND SUPPORT IN THE AMOUNT
OF P45.5 MILLION FOR THE FOLLOWING PROJECTS IN
ORDER OF PRIORITY TO BE FUNDED UNDER THE FISCAL
YEAR 2021 LOCAL GOVERNMENT SUPPORT FUND –
OTHER FINANCIAL ASSISTANCE TO LGUs (LGSF-OTHER
FA TO LGUs).

WHEREAS, pursuant to Section 16 of Republic Act No. 7160 of the Local
Government Code, every Local Government Unit shall exercise their powers
expressly granted, those necessarily implied therefrom, as well as powers
necessary, appropriate or incidental to its efficient and effective governance, and
those which are essential to the promotion of the general welfare of their
inhabitants;

WHEREAS, in order to confront rising public expectations relative to the
delivery of basic services, the Municipal Development Council of the Local
Government of Mangaldan, Pangasinan identified programs, projects and activities
to enable them to provide efficient and effective governance to its constituents;

WHEREAS, cognizant of the need to provide support to the LGUs, the Department of Budget and Management prescribed guidelines through Local Budget Circular No. 131 dated January 8, 2021 regarding the release and utilization of the Local Government Support Fund – Other Financial Assistance to Local Government Units (LGSF-Other FA to LGUs) Fiscal Year 2021, General Appropriations Act, RA No. 11518;

WHEREAS, programs, projects and activities with its corresponding budgets were identified by the Municipal Development Council, in order of priority, to drive socio-economic development of the municipality to be funded under the LGSF-Other FA to LGUs FY 2021, namely:

1. Construction of Solar Powered Street Lights along national highway and various notable road networks	P30,000,000.00
2. Purchase of Ambulance (1 unit)	2,500,000.00
3. Purchase of Mini Dump Trucks (2 units)	4,000,000.00
4. Purchase of Boom Truck (1 unit)	5,000,000.00
5. Purchase of Multi-Purpose Vehicles (2 units)	4,000,000.00
TOTAL	P45,500,000.00

WHEREAS, the programs, projects and activities mentioned in the next preceding paragraph has already been incorporated in the Supplemental Annual Investment Program (AIP) No. 1 for CY 2021 of the Municipality of Mangaldan;

WHEREAS, the proposed projects are part of the duly approved Local Development Investment Program and Annual Investment Program of the Local Government Unit of Mangaldan, Pangasinan;

WHEREAS, after careful review, deliberation and consideration, the same is found to be in conformity with the thrust of the Municipal Government and contribute to the attainment of the development goals and objectives of the municipality;

WHEREFORE, on motion of Councilor Atty. Joseph Emmanuel B. Cera duly seconded by other members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan strongly endorses to the DBM for financial assistance and support in the total amount of P45.5 Million for the following projects in order of priority to be funded under the FY 2021 Local Government Support Fund – other Financial Assistance to Local Government Units (LGSF-other FA to LGU's);


