RESOLUTION NO. 2021 – 42

RESOLUTION STRONGLY APPROVING/AUTHORIZING  
THE UTILIZATION OF P100,000.00 FOR THE  
PROCUREMENT OF REAGENTS AND KITS FOR COVID-19  
TESTING TO BE FUNDED UNDER THE FY 2021 LOCAL  
GOVERNMENT SUPPORT FUND DISASTER  
REHABILITATION AND RECONSTRUCTION ASSISTANCE.

WHEREAS, Section 15 of the 1987 Philippine Constitution provides, the  
State shall protect and promote the right to health of the people and instill healthy  
consciousness among them;

WHEREAS, on September 11, 2020, President Rodrigo Roa Duterte signed  
into law the Republic Act No. 11494 or the "Bayanihan to Recover as One Act"  
which intend to provide COVID-19 response and recovery interventions and  
mechanism to bolster the resiliency of the economy;

WHEREAS, the COVID-19 pandemic caused an immense impact in the  
health and safety of individuals, even ensued economic slowdown as evidence by  
the reduction of income, increased unemployment rate, hence puts significant  
pressures to the government;

WHEREAS, the Department of Budget and Management issued Local Budget Circular No. 134 dated January 20, 2021 which prescribed the guidelines on the release and utilization of the Local Government Support Fund-Disaster Rehabilitation and Reconstruction Assistance Program (LGSF-DRRAP) in the Fiscal Year 2021 General Appropriations Act, Republic Act No. 11518;

WHEREAS, the emergence of COVID-19 to numerous areas throughout the world, necessitate vigilance and preparedness in procuring Reagent and Testing Kits that are vital for an early detection and in combating COVID-19 to be funded under the LGSF-DRRAP FY 2021;

WHEREAS, the proposed project is part of the duly approved Local Disaster Risk Reduction and Management Plan and incorporated in the Local Development Investment Program and Annual Development Program of the Municipality of Mangaldan;

WHEREAS, the procurement of Reagents and Kits for COVID-19 testing has already incorporated in the Supplemental Annual Investment Program (AIP) No. 1 for CY 2021 of the Municipality of Mangaldan;

WHEREAS, after careful review, deliberation, the same is found to be in conformity with the thrust of the Municipal Government in the delivery of basic health services that would contribute to the attainment of the development goals and objectives of the municipality;

WHEREFORE, on motion of Councilor Atty. Joseph Emmanuel B. Cera duly seconded by other members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan strongly approves/authorizes the utilization of P100,000.00 for the procurement of Reagents and Kits for COVID-19 testing to be funded under the FY 2021 Local Government Support Fund-Disaster Rehabilitation and Reconstruction Assistance;




