RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. MARY MARILYN DG. LAMBINO TO PROVIDE CASH INCENTIVE TO ALL BLOOD DONORS IN THE AMOUNT OF TWO HUNDRED PESOS (P200.00) EACH IN THE CONDUCT OF "DUGONG ALAY, SAGIP BUHAY 2021 BLOOD LETTING PROJECT" OF THE LOCAL GOVERNMENT UNIT IN ALL THIRTY (30) BARANGAYS OF MANGALDAN, PANGASINAN CHARGEABLE AGAINST THE GENERAL FUND OF THE MUNICIPALITY.

WHEREAS, pursuant to Republic Act No. 7719, also known as the National Blood Service Act of 1994, promotes voluntary blood donation to provide sufficient supply of safe blood and to regulate blood banks.

WHEREAS, the municipality of Mangaldan will be having a blood letting activity dubbed "Dugong Alay, Sagip Buhay 2021". This aims to create public consciousness on the importance of blood donation in saving the lives of millions of Filipinos;

WHEREAS, a blood donation is truly an altruistic gift that an individual can give to others in need. Donating blood of a healthy person also helps the body boost production of red blood cells, reduce the risk of heart attack, lower cholesterol levels, contributes in giving the skin a healthier glow, reduce stress and improve emotional well-being;

WHEREAS, the local administration has arrogated unto themselves that fiat of giving importance to its partners in promoting health awareness to the people in adherence to the provisions of Section 15 of the 1987 Philippine Constitution which provides that the State shall protect and promote the right to health of the people and instill health consciousness among them. Accordingly, in recognition to blood donors civic duty in saving lives, the local government of Mangaldan has thought of providing cash incentive as thanksgiving to all participants of this Blood Letting Project;

WHEREAS, the Sangguniang Bayan of Mangaldan is cognizant and in full support to all the program, projects and activities being made by the Local Chief Executive for the welfare of the people of Mangaldan;

WHEREFORE, on motion of Councilor Maria Teresa M. Abalos duly seconded by other members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan authorizes the Local Chief Executive Hon. Mary Marilyn DG.
