


RESOLUTION NO. 2021 – 49

RESOLUTION AUTHORIZING THE 2021 ANNUAL BUDGET OF BARANGAY NIBALIW IN THE AMOUNT OF FOUR MILLION SIX HUNDRED NINETY FIVE THOUSAND NINE HUNDRED TWELVE PESOS AND 17/100 (P4,695,912.17) OPERATIVE FOR THEIR OPERATIONS COVERING THE FISCAL YEAR 2021 AS CONTAINED IN THEIR APPROPRIATION ORDINANCE DULY APPROVED BY THEIR SANGGUNIANG BARANGAY.

WHEREAS, forwarded to this body is Annual Budget for Fiscal Year 2021 of Barangay Nibaliw, Mangaldan, Pangasinan as authorize by the Sangguniang Barangay under their Appropriation Ordinance No. 1;




