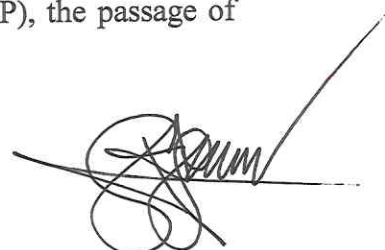
RESOLUTION NO. 2021 – 52

which is being in accordance with law;



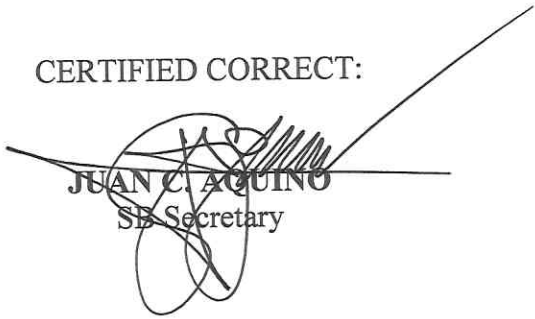

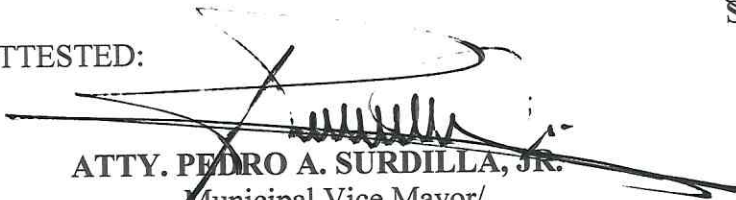
