RESOLUTION NO. <u>2021 – 66</u>

RESOLUTION APPROVING BARANGAY ORDINANCE NO. 01, SERIES OF 2021 OF THE SANGGUNIANG BARANGAY OF GUESANG, "AN ORDINANCE IMPOSING TAXES, FEES AND CHARGES IN BARANGAY GUESANG, MANGALDAN, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BARANGAY TO ENACT.

WHEREAS, pursuant to Chapter IV, Section 391 (a)(1) of Republic Act No. 7160, otherwise known as the Local Government Code, provides "the Sangguniang Barangay, as the legislative body, shall enact ordinances as may be necessary to discharge the responsibilities conferred upon it by law to promote the general welfare of the inhabitants therein";

WHEREAS, paragraph (a)(2) of Section 391 of the same code further strengthen barangay powers to enact tax and revenue ordinances, subject to the limitations imposed by law;

WHEREAS, Barangay Ordinance No. 01, Series of 2021 of Barangay Guesang, Mangaldan, Pangasinan was endorsed to Sangguniang Bayan for appropriate legislative action;

WHEREAS, the Sangguniang Bayan, as the legislative body of the municipality, shall enact ordinances, review all ordinances approved by the Sangguniang Barangay to determine whether these are within the scope of the prescribed powers of the Sanggunian;

WHEREAS, the Sangguniang Bayan conducted a committee hearing with the attendance of Barangay Officials and thoroughly reviewed and deliberated the said ordinance and found out that the same is complete in form and substance;

WHEREFORE, on motion of Councilor Atty. Fernando Juan A. Cabrera and duly seconded by the other members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan approves Barangay Ordinance No. 1, Series of 2021 of the Sangguniang Barangay of Guesang, "An Ordinance Imposing Taxes, Fees, and Charges in Barangay Guesang, Mangaldan, Pangasinan" as within the conferred powers of the Sangguniang Barangay to enact;

RESOLVED FURTHER, that copies of this resolution be furnished the Sangguniang Barangay of Guesang through Punong Barangay Hermogenes N. Sembrano, the MLGOO, Mrs. Romarie P. Soriano, the Commission on Audit through Mrs. Marina P. De Guzman, Audit Team Leader, the Office of the Municipal Mayor, Hon. Mary Marilyn DG. Lambino and all other authorities concerned for their information and favorable action.
